RATES AND PAYMENT

Rates are per day including the day of arrival and day of departure. Outstanding balance should be paid at the time of collecting the dog. Payment can be made by Credit/Debit Card, Cheque (made payable to Judy Hempstead), Cash or Bank Transfer (BACS). BOOKING

Provisional bookings can be made by telephone or email. However, to secure the kennel for the date agreed a 50% deposit and completed booking form is required. A booking form can be downloaded from the website: https://www.whipcurlcanineresolve.com

Kennels are booked on a 'First Come First Serve' basis. Please return the booking forms within 7 days to secure your dog/s space along with the 50% deposit. Failure to do so may result in the kennel being allocated to another dog. Forms will not be accepted if returned on the day unless by prior agreement. The owner has the right to refuse entry.

HEALTH

Dogs can only be accepted on condition they have been fully inoculated against Distemper, Hepatitis, Leptospirosis, Parvo virus and Intrac within the last twelve months and not less than two weeks prior to their kennel stay or training. Vaccination certificates must be shown on the day off arrival or a copy sent with the booking form.

All kennel cough vaccines must be administered at least 2 weeks prior to boarding. Should any animal be found to be hosting fleas, the person responsible for collecting the animal will at the time of collection, be liable for all costs of treating the animal and surrounding environment considered necessary by the owners of *WhipCurl Canine Resolve*. Animal(s) showing signs of kennel cough or any other contagious disease will be turned away.

BEDDING/LEADS

WhipCurl Canine Resolve will provide suitable bedding/leads. Owners may bring their own beds/leads but do so at their own risk. The owners or staff will not accept any responsibility for damage to the owners bedding or equipment left at the kennels. Destroyed or soiled bedding with be disposed of.

SECURITY AND ANIMAL WELFARE

The kennels/home boarding environment are fully secured for the safely of the animals. No owners (unless invited or agreed prior to drop off) will be allowed to take their animal(s) into the kennel area. Whilst in our care no animal(s) will be allowed

visitors as this can upset them (unless by prior arrangement). All animals must be fit, in sound condition, and of pleasant disposition. In the event of your animal falling ill, we reserve the right to call in a veterinary surgeon. All costs to be borne by the owner. This will include any veterinary call-out charges, transportation etc. It is the owner's responsibility to ensure there are sufficient funds to cover this. It is emphasized whilst every care and attention is given; the proprietors accept no responsibility for injury due to your animal(s) whilst training in our kennels. ALL dogs must be on a lead at all times unless agreed with the kennel staff. Collars being worn by dogs must be secure WhipCurl Canine Resolve accept no responsibility for loss or injury. The proprietors reserve the right to turn away any animal they feel is not suitable to be trained.

KENNEL DETAIL

Drop off and collection times are between 8.00am to 9.00am and 4.00pm to 4.30pm. With advanced request other times can be arranged. Dogs must be collected on stated day out. Any Animal left longer than dates reserved will be charged £10.00 per day more than the normal rate. In the event of an animal not being collected within 7 days, we will try to trace/communicate with owner/contact before proceeding with legal action.

No animal(s) will be accepted into the kennel without a UK contact name, address and telephone number. Owners/contacts will be asked to remove difficult animal(s) from the kennels. Owners must make the contact aware of this responsibility.

Cancellations

In the event of a cancellation, within 1 month of the intended booking, the 50% deposit will not be returned unless the kennel space can be filled. If the cancellation is received within 1 week of the booking then the deposit will **not be returned** unless the dog has deceased. Full payment will be required unless the kennel space can be filled. If the owner returns earlier to collect the dog than agreed on the booking form, the owner will still be liable for the full cost of the dogs stay unless by prior agreement.

I understand that while every care will be given to my animal/s they are boarded at my own risk.

I authorise WhipCurl Canine Resolve to call a veterinary surgeon on my behalf should you consider it necessary.

We at WhipCurl Canine Resolve reserve the right to contact animal welfare should the animal/s not be collected within 14 days of the stated departure date if no communication from the owner is received and if reasonable efforts to contact the owners or their representatives fail.
